Upon registering in Cal North's Data Management System as a team administrator, board member, staff member, or another volunteer, and printing out the Request for Live Scan Form, you must:

1. Either go to a league sponsored event or an approved Live Scan vendor to be fingerprinted
2. Complete your Safe Sport Core/Refresher training
3. Complete Introduction to Safe and Healthy Playing Environments (the Safe and Healthy Playing Environments course has replaced the CDC's HeadsUp Concussion Training)

Completing Live Scan

Contact your league for information regarding upcoming league fingerprinting events.

If your league is not holding a fingerprinting event, visit

https://www.applicantservices.com/live_scan_locations to locate an approved vendor that is in your area. If you go to an approved vendor, your League/Club will be billed for the fingerprinting. If you go to a vendor that is not approved and found using the link above, you will have to pay the vendor fee for the fingerprinting unless your League/Club has made other arrangements and your League/Club will be billed for the processing of the results.

Prior to arriving at a Live Scan location:

1. Ensure that all Applicant and Home Address data fields are correctly filled out
2. Verify that the District, League, Club, and Admin ID numbers are correct. Contact your Registrar if you do not know your District/League/Club and Admin ID number
3. Sign and date the form and take the form with you to the Live Scan location
4. You will need to provide a current valid photo ID (eg: California Driver's License, California ID card, out-of-state driver's license, Military Id, passport, Resident Alien Card)

If going to an approved Capital Live Scan vendor:

1. The Contract Code will be used to identify Cal North as the organization
2. After being fingerprinted, obtain the ATI number from the vendor for your records

If there is not a Capital Live Scan location in your area you may go to any vendor that is certified and approved by the Department of Justice. The following information will need to be provided:

1. Cal North ORI Code: AE689
2. The organization is Cal North, 1040 Serpentine Lane, #206, Pleasanton, CA 94566
3. Level of Service is DOJ
4. OCA Number
5. After being fingerprinted, obtain the ATI number from the vendor for your records

Completing Safe Sport Training

1. To complete Safe Sport training you must go to

2. US Soccer should be selected as your organization
3. You will be prompted to enter Access Code: **YC3E-6P5G-YYIL-CS2M**
4. If you have not already created an account with Safe Sport, you will need to do so to access the training
5. When creating your account, you must use the same info you used when you registered in the Cal North registration system i.e. First name, last name, email address, etc.. must match
